Is Subcontracting allowed?	Subcontracting is allowed, provided that the extent/portion of the project to be subcontract is <b>not more that 50% of the project.</b>
	And must be in accordance and conformed with Section II. ITB Cluse 7 of the bidding document, which states:
	"The Bidder must submit together with its Bid the documentary requirements of the subcontractor(s) complying with the eligibility criteria stated in ITB Clause 5 in accordance with Section 23.4 of the 2016 revised IRR of RA No. 9184 pursuant to Section 23.1 thereof." Xxx
	Note: The bidder shall identify the subcontract total work and its total cost and must appear clearly on their financial proposal.
